- THIS SHOW IS OPEN TO DWS MEMBERS ONLY.
- 60 ENTRIES WILL BE ACCEPTED FOR THIS SHOW.  
(Mail in Entry Fee (\$30) as per ENTRY Form and upload your digital entry/entries)
- UP TO 3 PAINTINGS PER ARTIST CAN BE ENTERED.
- REHOBOTH ART LEAGUE SHALL SET THE ARTWORKS AT THE RETAIL PRICES GIVEN BY THE ARTIST(S). ALL SALES ARE TO BE PROCESSED BY RAL. THE ARTIST(S) WILL RECEIVE SIXTY-FIVE (65%) PERCENT FOR THE SALES OF ANY ARTWORKS SOLD AND RAL SHALL RETAIN A THIRTY-FIVE (35%) PERCENT COMMISSION OF THE SALE PRICE OF ANY ARTWORKS SOLD. PAYMENTS ARE MADE MONTHLY.
- THE JUROR FOR THIS SHOW IS MARIE NATALE.

- DELIVERY OF ARTWORK TO SHOW – MARCH 28 THROUGH MARCH 30.
